Pesah, the 15th of Nisan, falls on Friday night and Saturday, April 10-11. Accordingly, the first Seder is on Friday evening.

Shabbat HaHodesh falls on Saturday, March 28. Shabbat HaHodesh always falls on the Shabbat preceding Rosh Hodesh Nisan or on Rosh Hodesh itself if it coincides with Shabbat. This year, Shabbat HaHodesh falls on Rosh Hodesh itself. The maftir read from the second Sefer is the portion beginning "This month shall be for you the head of the months; it is the first for you of the months of the years." (Shemot 12.) The haftorah is from *Ezekiel*, chapter 45.

The Shabbat before Passover is Shabbat HaGadol (April 4). There are a number of interpretations as to why it is called the "Great" Shabbat. One view is that it is called the "Great" Shabbat because of the miracles performed on this day immediately preceding the departure of the Israelites from Egypt. Another view is that the name comes from the haftorah read on this day, which is from Malachi. In the haftorah, Malachi prophesies; "Lo, I will send the prophet Elijah to you before the coming of the great and awesome day of the Lord." (Malachi 3:23) As Francine Klagsbrun writes, "In Jewish lore, Elijah will herald the arrival of the Messiah, and according to some reckonings, both will appear in the month of Nisan. This Sabbath is special because it introduces the theme of messianic redemption that will crop up time and again through the holiday of redemption now on the horizon." F. Klagsbrun, Jewish Days: A Book of Jewish Life and Culture Around the Year (1996) (reprinted with permission of the author).

The search for the leaven (Bedikat Hametz) is to be conducted on Thursday evening, April 9. No hametz is to be eaten after 10:47 a.m., and all hametz must be sold by 11:53 a.m. on April 10 (though you will have to contact Rabbi Wechsler by the Siyum Minyan). On erev Pesah, Friday morning,

we will daven shaharit at 7:30 a.m. in the Synagogue to mark the Fast of the First Born. A full schedule of the services for Passover is on page 8 and in the calendar on page 5.

One of the centerpieces of the Haggadah and of the Exodus account is the recounting of the ten plagues. The structure of the ten plagues is discussed in great depth by Professor Nahum Sarna in his study, Exploring Exodus: The Heritage of Biblical Israel (1986). A brief excerpt is set out below for your reference:

"The plagues are arranged in the form of three series of calamities comprising three afflictions in each series. The tenth is climactic and lies wholly outside the series in that it, alone, has no grounding in natural events. It belongs in the realm of the supernatural. Within each series, the first two plagues are each preceded by divine forewarning, while the third strikes each time unheralded. Again, in the case of the first plagues in each series Moses is bidden to confront the pharaoh 'in the morning,' but no time indication is given with respect of the other two. Also common to the first, fourth, and seventh plagues is the manner in which God's instruction to Moses is formulated. He is told, 'Station yourself' before the pharaoh; the verbal stem y-ts-b is used each time. The second, fifth, and eighth plagues share the introductory formula, 'Go to Pharaoh,' in which the verb b-w-' is uniformly employed. The third plague in each series has no common instruction formula. Finally, the entire first series of the three plagues is wrought through the instrumentality of Aaron, the entire last series is accomplished through the agency of Moses."

Yom Ha-Atzmaut Israel Independence Day

Yom Ha-Atzmaut, Israel Independence Day, will occur this year on Wednesday evening, April 29 and Thursday, April 30. Or Zarua will celebrate on Wednesday evening with special services and lectures.

Since the day before Independence Day is observed in Israel as Yom Hazikaron, Memorial Day for all the soldiers who fell in establishing and defending the Jewish State, our observance will begin with a special Yom Hazikaron Minhah service which will begin at 7:30 p.m. At this Service, Prof. Ann Lerner, Vice Chancellor of the Jewish Theological Seminary and Professor of Hebrew Literature, will speak on the poetry of Israel's War for Independence.

This service will be followed by the special prayers for Yom Ha-Atzmaut, which will include the blowing of the shofar. Following the service we will celebrate with Israeli food and music, and Prof. Lerner will deliver a second lecture on Hebrew Literature of the New Jewish State.

Building News

With only \$500,000 to go, our new building is daily becoming more and more of a reality, a result of significant activity on both the fund-raising and planning fronts.

In particular, the Capital Campaign has gained new momentum in recent weeks. With new pledges of \$868,000 from our end-of-year blizzard, our campaign coffers have swelled to approximately \$1,650,000 in cash and \$1,500,000 in pledges. This means that we are only \$500,000 short to be in a position to begin construction, assuming borrowing of \$1,500,000 unless continued generosity makes borrowing unnecessary. In the meantime, the Building Committee has been meeting regularly with the architect, R. G. Roesch, dealing with the nitty-gritty required to complete the plans. In the process we have made some changes to the schematic plans on view in the synagogue basement - including a larger social hall! Shortly, we should have a new set available for all to see. Throughout the process, our primary goal has been to maximize the utility of the space to meet the congregation's many and varied needs. We currently expect the plans to be completed in June 1998 and hope to begin construction of our new home in the late summer.



Extend Your Celebration of Shabbat with Or Zarua

On the first Shabbat of each secular month, an hour before candlelighting time of the previous evening, we celebrate Shabbat with minhah, followed by a seudah shlishit and Havdalah services to end Shabbat. The tradition of celebrating Shabbat with a seudah shlishit (or "third meal") is an old one.

We gather downstairs, eat a light and delicious meal, and sing Shabbat nigunnim to bring Shabbat to a close. We then complete the Shabbat with Havdalah.

For those of you who have not experienced this aspect of Shabbat, we encourage you to join our intimate group. The dates and times are indicated in the Or Zarua newsletter calendar.

Yom HaShoah Service Wednesday, April 22nd, 8 P.M.

Yom Hashoah, the Day of Remembrance for the Jewish victims of the Holocaust occurs this year on Wednesday evening, April 22 and Thursday, April 23. At 8:00 p.m. on April 22, Or Zarua will hold its annual Maariv service in observance of Yom Hashoah. Prayers are recited at that time and a roll-call is read of all those friends and loved ones of members of the Congregation who perished during the Shoah. It is a time of intense reflection and memorial.

This year, as part of Or Zarua's observance, a panel of congregants will address the Congregation as part of the service. Each the panel's members is a refugee whose family was dislocated by the Shoah and who found refuge in the United States. Children during the war, each of these members will recall the experiences of his and her family. The panel will consist of Evelyn Schwartz, whose family was in France, and Abraham Asher, whose family came from Germany. The moderator will be Sam Klagsbrun, a wartime refugee from Belgium.

Guidelines for Passover

This guide was prepared by the Rabbinical Assembly Committee on Jewish Law and Standards by Rabbi Mayer Rabinowitz. It was accepted by the Committee on December 12, 1984. The last paragraph of the introduction and Part A under "Permitted Foods," have been amended to reflect more recent decisions of the Committee affecting the status of peanuts, peanut oil and certain cheeses.

The Torah prohibits the ownership of hametz during Pesah. Therefore, we arrange for the sale of the hametz to a non-Jew. The transfer, mekhirat hametz, is accomplished by appointing an agent, usually the rabbi, to handle the sale. It is a valid and legal transfer of ownership. At the end of the holiday, the agent arranges for the reversion of ownership of the now-permitted hametz. If ownership of the hametz is not transferred before the holiday, the use of this hametz is prohibited after the holiday as well (hametz she-aver alav ha-Pesah).

Since the Torah prohibits the eating of hametz during Pesah, and since many common foods contain some admixture of hametz, guidance is necessary when shopping and preparing for Pesah. During the eight days of Pesah, hametz cannot lose its identity in an admixture. Therefore, the minutest amount of hametz renders the whole admixture hametz and its use on Pesah is prohibited. However, during the rest of the year, hametz follows the normal rules of admixture, i.e., it loses its identity in an admixture of one part hametz and sixty parts of non-hametz. This affords us an opportunity to differentiate between foods purchased before and during Pesah.

What follows is a general guideline. However, Rabbi Wechsler should be consulted when any doubt arises.

Kosher le-Pesah labels that do not

bear the name of a rabbi or one of the recognized symbols of rabbinic supervision, or which are not integral to the package, should not be used without consulting Rabbi Wechsler.

Prohibited foods include the following: leavened bread, cakes, biscuits, crackers, cereals, coffees containing cereal derivatives, wheat, barley oats, spelt, rye and all liquids containing ingredients or flavors made from grain alcohol. Ashkenazic authorities have added the following foods (kitniyot) to the above list: rice, corn, millet, legumes (beans and peas; however, string beans are permitted). The Committee on Jewish Law and Standards has ruled unanimously that peanuts and peanut oil are permissible, as peanuts are not actually legumes. Some Ashkenazic authorities permit, while others forbid, the use of legumes in a form other than their natural state, for example, corn sweeteners, corn oil, soy oil. Sephardic authorities permit the use of all of the above. Consult Rabbi Wechsler for guidance in the use of these products.

Permitted foods: A. The following foods require no kosher le-Pesah label if purchased prior to Pesah: unopened packages or containers of natural coffee without cereal additives (however, be aware that coffees produced by General Foods are not kosher for Passover unless marked KP); sugar, pure tea, salt (not iodized); pepper, natural spices; frozen fruit juices with no additives; frozen (uncooked) vegetables (for legumes, see above); milk; butter; cottage cheese; cream cheese; ripened cheeses such as cheddar (hard), Muenster (semisoft) and Camembert (soft); frozen (uncooked) fruit (with no additives); baking soda. B. The following foods require no kosher *le-Pesah* label if purchased before *or* during *Pesah*: fresh fruits and vegetables (for legumes, see above), eggs, fresh fish and fresh meat.

C. The following foods require a kosher le-Pesah label if purchased before or during Pesah: All baked products (matzah, cakes, matzah flour, farfel, matzah meal and any products containing matzah); canned or bottled fruit juices (these juices are often clarified with kitniyot which are not listed among the ingredients. However, if one knows there are no such agents, the juice may be purchased prior to Pesah without a kosher le-Pesah label); canned tuna (since tuna, even when packed in water often has been processed in vegetable broth and/or hydrolyzed protein - -however, if it is known that the tuna is packed exclusively in water without any additional ingredients or additives, it may be purchased without a kosher *le-Pesah* label); wine, vinegar; liquor, oils, dried fruits; candy; chocolate flavored milk; ice cream; yogurt; and soda.

D. The following processed foods (canned, bottled or frozen) require a kosher te-Pesah label if purchased during Pesah: milk, butter, juices, vegetables, fruit, milk products, spices, coffee, tea and fish, as well as all foods listed in category C.

Detergents: If permitted during the year, powdered and liquid detergents do not require a kosher *le-Pesah* label.

Medicine: Since hametz binders are used in many pills, the following guidelines should be followed: If the medicine is required for life sustaining therapy, it may be used on Pesah. If it is not for life sustaining therapy, some authorities permit, while others prohibit. Consult

Rabbi Wechsler. In all cases, capsules are preferable.

Kashering of utensils: The process of kashering utensils depends on how the utensils are used. According to halakhah, leaven can be purged from a utensil by the same process in which it was absorbed in the utensil (ke-voleo kakh poleto). Therefore, utensils used in cooking are kashered by boiling, those used in broiling are kashered by fire and heat, and those used only for cold food are kashered by rinsing.

A. Earthenware (china, pottery, etc.) may not be *kashered*. However, fine translucent chinaware which has not been used for over a year may be used if scoured and cleaned in hot water.

B. Metal (wholly made of metal) utensils used in fire (spit, broiler) must first be thoroughly scrubbed and cleansed and then made as hot as possible. Those used for cooking or eating (silverware, pots) must be thoroughly scrubbed and cleaned and completely immersed in boiling water. Pots should have water boiled in them which will overflow the rim. Pans in which bread or cake have been baked may not be kashered.

C. Ovens and Ranges: Every part that comes in contact with food must be thoroughly scrubbed and cleaned. Then, oven and range should be heated as hot as possible for a half hour. If there is a broil setting, use it. Self-cleaning ovens should be scrubbed and cleaned and then put through the self cleaning cycle. Continuous cleaning ovens must be kashered in the same manner as regular ovens.

Microwave ovens, which do not cook the food by means of heat, should be cleaned, and then a cup of water should be placed inside. Then the oven should be turned on until the water disappears. A microwave oven that has a browning element cannot be *koshered* for *Pesah*.

D. Glassware: Drinking glasses require a thorough scrubbing before *Pesah*, or putting them through a dishwasher.

E. After not using the dishwashing machine for a period of 24 hours, a full cycle with detergent should be run.

F. Electrical Appliances: If the parts that come into contact with hametz are removable, they can be kashered in the appropriate way (if metal, follow the rule for metal utensils). If the parts are not removable, the appliance cannot be kashered. (All exposed parts should be thoroughly cleaned).

G. Tables, closets and counters: If used with *hametz*, they should be thoroughly cleaned and covered, and then they may be used.

H. Kitchen Sink: A metal sink can be kashered by thorough cleaning and then pouring boiling water over it. A porcelain sink should be cleaned and a sink rack used. If, however, dishes are to be soaked in a porcelain sink, a dish basin must be used.

I. Hametz and Non-Passover utensils: Non-Passover dishes, pots and hametz whose ownership has been transferred, should be separated, locked up or covered, and marked in order to prevent accidental use.
